The timeframe will be dependent on a number of variables which are unknown at this time, including but not limited to: the date by which final permits and licenses are received, potential time-of-year permit conditions, equipment manufacturer fabrication timelines, and the availability of facility outages needed to facilitate certain aspects of the construction.

For a project of this nature and scale, National Grid anticipates that an overall duration of 30 to 42 months could be required to plan, design, construct and energize the project after receiving Notice to Proceed and security.
